While grappling with the **mandated closure of our office at the Mississauga Valley Community Centre (MVCC), we have had to modify operations (Delivery of Program/Service) and cancellation of some of our regular programs and services, performances, workshops, gatherings, events, including shifting from in-person programming to remote (on-line) virtual operations.**

Consequently, **CACD will be focusing this Spring Semester (April 5, 2021 to June 30, 2021) on a project that addresses the following:**



(1) Improve Academic and Educational skills Development/Health and Wellness; (2) facilitate transitions to the labour market through training, networking, career counselling, access to labour information, the new economy (Co-ops, Internship, placement, apprenticeship); (3) Leadership and Mentorship (4) Digital literacy & innovation skills for future jobs; (5) Black Canadian history/anti-black racism and discrimination; (6) Start-up business, entrepreneurship & financial literacy.
